



BOOKING CONDITIONS

Please read and sign the following booking conditions for your 7holes Ultra Caving Run. Then send us back this signed document to the following address : registrations@7holes.eu.

PAYMENTS

Payments must be made by wire transfer in Euros (€).

DEPOSIT

A non-refundable deposit of 1 860€ is payable to secure your place on the 7holes Ultra Caving Run.

REGISTRATION

Your registration is effective when our offices have correctly received your deposit **AND** this signed document. Once these 2 conditions are met, a confirmation email will be sent to you. The number of places being limited to 4 people per week, it is important to note that only a person having fulfilled the 2 conditions above will see his registration confirmed and his place reserved.

BALANCE

Once your registration has been confirmed, your 7holes is also confirmed, subject to payment of the balance, according to the following terms and conditions :

- If the participant's registration date is prior to March 31, 2019,
The balance of 6 000€ is payable in two instalments of 3 000€ :
 - ✓ The first, 30 days after the registration date,
 - ✓ The second, 45 days after the registration date.
- If the participant's registration date is after March 31, 2019,
 - ✓ The balance of 6 000€ is payable in one go, before May 15, 2019.

CANCELLATION AND REFUND

A participant may cancel his/her participation, according to the following terms and conditions :

- Prior to 31 March 2019, on the basis of a 50% refund of the March 31 balance payment.
- After 31 March 2019, on the basis of no refund of any monies paid.

RECEIPTS

We will send you receipts for all payments.

SERVICES INCLUDED IN THE PRICE

The services included in the price are as follows :

- 2 guides / 4 people
- 2 logistics operators / 4 people, from day 3 until the end of the race
- Radio link during the race
- Individual caving equipment
- Collective caving equipment
- Bivouac equipment
- Supply and production of media elements for distribution on social networks and the press
- Round trip transport between Grenoble (station or airport) and the accommodation
- Round trip transport between the accommodation and practice sites

SERVICES EXCLUDED FROM THE PRICE

The services excluded from the price are as follows:

- Travel to and from Grenoble
- Accommodation and meals during the week
- Visas for entry into French territory
- Supplements during the week
- Clothing and personal effects
- Tips for guides and team staff
- Personal insurance
- Medical evacuation insurance

This agreement and the operations resulting from it are subject to French law. It is written in French and translated into English. It is agreed that the court of Grenoble (France) shall have exclusive jurisdiction in the event of any dispute to which this agreement may give rise, concerning its validity, interpretation, execution, termination, consequences and consequences. In the event of a dispute, the French text shall be the only authentic text.

Cyrille MATHON Company reserves the right to modify the itinerary, the date of departure or the end date of the 7holes Ultra Caving Run due to dangerous terrain, weather conditions, health, political situation or for any other reason questioning the feasibility of the race.

In the event of a change of itinerary, a change in the duration of the itinerary, a change of date, postponement, cancellation, injury, loss or accident, the participant has no right of compensation or repayment of payments (in part or in full).

Neither Cyrille MATHON Company nor the Participant shall be held liable for any breach of any of their obligations under this Agreement, if such breach is attributable to an unavoidable or unforeseeable event that is beyond the control of Cyrille MATHON Company or the participant, and which would occur after the date of signature of this agreement.
